   Collaborated in design and implementation of monitoring and evaluation strategy. Proactively identified and addressed program issues and opportunities using monitoring and evaluation methods to continuously improve the effectiveness of the program, my students, staff, colleagues, and myself.

- Implemented theory and strategies of development to directly manage 20 students, providing intellectual, academic, cultural and social support for academic achievement and character and career development. My students received 60% of available program awards annually while comprising only 25% of eligible students. Generated 84% retention of my students over three years compared to a program average of 50%.
- Kept records on each student for all growth areas, including academic, and organized supportive
  interventions with relevant stakeholders such as teachers, parents, and program staff when students
  were not progressing. Also used these records to create individualised achievement strategies with
  each student that fit their needs and goals and coached them on continued application of the
  strategies.
- Planned and delivered weekly workshops, planned and managed events and budgets, managed 5 staff, assisted with recruitment and hiring, lead trainings, and engaged stakeholders.
